2024 FCA US LLC Sweepstakes OFFICIAL RULES

THE FOLLOWING SWEEPSTAKES IS INTENDED FOR ENTRY IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO UNITED STATES LAW. WHEN TO ENTER: The 2024 FCA US LLC Sweepstakes ("Sweepstakes") starts at 12:00:01 a.m. Central Time ("CT") on January 1, 2024 and ends at 11:59:59 p.m. CT on December 31, 2024 (the "Sweepstakes Period").

HOW TO ENTER:

There are three (3) ways to enter the Sweepstakes:

WHO CAN ENTER (Eligibility): This Sweepstakes is open only to legal residents of the fifty (50) United States and Washington D.C., who are age eighteen (18) or older at time of entry and have a valid U.S. driver's license.
